Seasonal Hours Subject to Change

- Lap:** Lengthwise swimming for adults and older children age 16+ (lane lines may be in use depending on the number of swimmers).
- Open:** Pool open to swimmers of all ages. Consists of a 15 minute break at the :45 of each hour for adult only swim, except for the last hour of open swim. Lap Swimming and Water Walking lane may be available depending on usage.
- Program:** Classes and Lessons only. Swimmers must register and pay in advance to participate. More information on pages 4-5.
- Group:** Available for private group rental. Rentals are available before or after pool hours when no other programs are scheduled. Suggested times are: Saturday after 6:00 PM; Sunday 10-11:00 AM; Tuesday-Friday after 7:00 PM. Call the HVCA office for available times.

2012 POOL RATES

Gate Fees: A gate fee is charged to enter the pool. Pool deck maximum capacity is 50 people, so the gate may be closed to the General Public if the number of people at the pool reaches 40. "Homestead Residents" are those who live in the CSA-14 tax district. Check at office or gate for residency clarification.

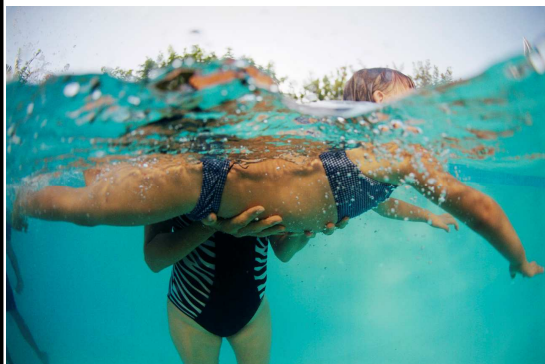

SWIM LESSON POLICIES

- Registration AND full payment are required in advance and in person at the HVCA office.
- Parents must notify HVCA of any special needs or medical conditions of their children and obtain instructor approval.
- **Cancellations must be 7 days in advance of lesson/class time to be eligible for a refund or re-schedule.**
- **Patron requested refunds are subject to a 10% Processing Fee.**
- Each swimmer will be tested at the beginning of the 1st class to determine appropriate skill level for Group Lessons.
- Students must sign in with instructor before each lesson.

“HOMESTEAD” PRIVATE LESSONS: (25 MIN)

Swim lessons are the best way to improve on any swimmer’s abilities. Our Homestead instructors will tailor your private lessons to improve those skills needed most! If you have two or more children with similar swimming abilities the Semi-Private option is available. Lessons are for all ages, including adults.

ADULT/CHILD SWIM (25 MIN)

Members: \$50.00 per session; General Public: \$60.00

MON.: 3:30 PM (18 MOS. & UNDER)

MON: 4:00 PM (19 MOS. TO 3 YRS.)

This is a water orientation course for very young children up to age 3 with parent. Learn to enjoy the water together through a variety of songs, games, and safety skills. Children are not expected to learn to swim in this class, but learn to cultivate parent/child trust. Parents need not be able to swim themselves. Begins April 23rd.

GROUP LESSONS (45 MIN)

Members: \$60.00 per session; General Public: \$75.00

SATURDAYS: 10:00 - 10:45 AM



Group lessons are a fantastic way for your swimmer to learn skills while having fun with their friends. Classes are for beginner and advanced beginner. Each session is 4 classes. Class minimum size is 3 with student to teacher ratio of 1:6. Advance registration is required. Begins May 12.

Session I: May 12, 19, 26, June 2
 Session II: June 9, 16, 23, 30
 Session III: July 7, 14, 21, 28
 Session IV: Aug. 4, 11, 18, 25

Programs and classes are offered for all ages, infants through seniors. Classes are ongoing throughout the season with 4 classes per session. Advance registration and payment are required to participate. Classes require a minimum enrollment of 3. Additional times and dates may be added based upon increased demand.

POOL AUTHORIZATION AND INDEMNITY AGREEMENT

Risk of Injury: I acknowledge that some pool activities may pose risks to me or my child(ren), including the risk of serious injury or death.

RULES AND PROCEDURES

1. A lifeguard must be present at all times during swimming.
2. All members and visitors must check in at the gate; swimmers must shower before entering the pool.
3. All swimmers must wear a bathing suit - babies must wear water-proof pants. (Available for purchase)
4. Diving is not permitted.
5. Running, pushing, or rough-play (splashing, dunking, throwing items) in pool area is prohibited.
6. Food, gum, beverages, glass, or smoking are prohibited.
7. Pets are not allowed.
8. Children under 10 must be accompanied by an adult.
9. No one with an infectious disease, cold, cough, sores, or bandages may swim.
10. Oil-based sun products are not allowed for swimmers.
11. Children who are “non-swimmers” must be accompanied by an adult in the pool.
12. Toys allowed only at the discretion of the lifeguard.
13. Please clean up after yourself; littering is prohibited, please use recycling cans.
14. Cell Phones must be set to non-audible alert.
